Motion to approve December minutes by Farrel Erickson, seconded by Kelman Kvien. Carried - unanimous.

John Anderson, new Director of the Roseau County ASCS, was present to meet the Board of Managers and expressed his willingness to work with them when needed.

Eng. Rood reported the following:

LOST RIVER - There was discussion on obtaining land from owners, and the possibility of including D# 18 into the project. Kelman Kvien may be able to start soil testing in the area.

SD #51 - Les Hagen has been removing trees. It is noted that Mr. Hagen had requested an increase in his hourly rate, which was approved by the Board.

DUXBY LEVEE - There are six culverts that need gates.

RRWMA - Stan Wood has requested a map showing all ditch systems maintained by the RRWD. Since no such map exist, there was discussion on what information would be needed. Sec. Ross will contact the Auditors Office and search old files. Also, files need to be set up for each ditch and an annual report should be made.

DIKED STORAGE - Informed by Dan Thul that the cost share is up to 25%.

The RRWD will host a dinner meeting for the Two Rivers Watershed District on January 13, 1992, at 7:00 p.m. at the supper club in Greenbush.

Motion by Farrell Erickson to approve January minutes with the following correction: the IRS Standard for mileage paid to Board members is .28 cents per mile, seconded by Robert Severson. Carried - unanimous.

Jeff Lewis and Willis Mattison were touring the District and sat in to observe the Board's meeting. Mr. Lewis made a request to have a copy of the minutes mailed to him each month.

Engineer Rood reported the following:

PALMVILLE - Met with the DNR. There was discussion about changing the design to 1 wildlife pool instead of two. A public meeting has been tentatively set for March 24, 1992 at 7:30 p.m. at the Wannaska School. The application for the Flood Damage Reduction Grant will also need to be resubmitted with the appropriate changes.

DIKED STORAGE - There was discussion regarding adjustments for those landowners who would be holding more floodwater for other farmers. The work request for the Section 22 Study by the Corp. of Engineers is now \$15,000.00. The Districts share of the contribution is up to 30% or \$4,500.00. A motion was made by Robert Severson to have the District proceed with the work request and contribute \$4,500.00, seconded by Farrell Erickson. Carried - unanimous.

ANNUAL REPORT - waiting for audit to be done.

Leslie Hagen submitted his bill for work completed and informed the Board of the progress he was making. Motion by Robert Severson to pay Leslie Hagen \$1,980.00 for tree removal, seconded by Farrell Erickson. Carried - unanimous.

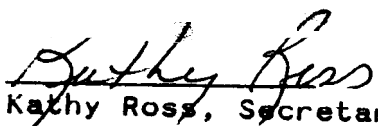

CEDAR BEND - Will request permission from Bob Phillipe to go on his land to take elevation shots.

LOST RIVER - Will look into acquiring 880 acres located east of the project.

Omar Rood, Robert Severson, and Kelman Kvien met with the Corp. of Engineers on Sect. 22. They did receive the money and are doing there analysis. Will start this summer. North of Roseau they are looking at making the flood ~~plane~~ smaller and improving the channel upstream. Pat Moren will be sending the economic data requested by the Corp.

Others attending were Eng. Omar Rood, Atty. Pat Moren, Sec. Kathy Ross, Roseau Co. Eng. Russ Larson, County Commissioner Glen Darst, Milfred Nelson, Lloyd Frosaker, Buddy Erickson and Leslie Hagen.

Motion by Farrell Erickson to approve March minutes with the following correction noted; the Cut Off Two Restoration Plan should be the Cut Off Two Restoration Project, seconded by Robert Severson. Carried - unanimous.

PALMVILLE - sent drawing to the State showing the changes made to the project, i.e. removed wildlife structure, extended inlet channel North. On 4-9-92 there will be a meeting in Bemidji with the DNR, Palmville and the Lake Bottom will be discussed.

LAKE BOTTOM and north of the City of Roseau - will work on defining the project and gathering economic data requested by the Corp.

ROSEAU RIVER - will send letters to Ruth Ringling and Kelly Falk regarding their request to fill in the river bank on their properties.

ANNUAL REPORT - waiting for audit to be finished.

HAY CREEK - as shown, the project would cost \$1,000,000.00 to complete and would be hard to fund. Wouldn't have DNR support. RRWD and RRWMB would need special assessments. Landowners could build their own dike following guide lines for a 100 year flood.

BOARD OF MANAGERS MEETING HELD MAY 5, 1992

Meeting called to order by Chairman Kelman Kvien at 7:30 p.m. in the Watershed Office in City Hall. Board members present were Kelman Kvien, Farrell Erickson, Robert Severson, Steve Erickson and Allison Frislie. Others attending were Eng. Omar Rood, Atty. Pat Moren, Sec. Kathy Ross, Roseau County Eng. Russ Larson and Scott Habstritt.

Motion by Farrel Erickson to approve April minutes, seconded by Robert Severson. Carried - unanimous.

Russ Larson reported to the Board that the County will be putting in a culvert, with trap, through Township Rd. #27, in Moose Township. This was agreed to by those concerned landowners who were present at April's meeting, and a letter will be sent stating the above action.

There was also a discussion with Mr. Larson regarding the removal of beavers. The ~~DNR~~ ^{County} is giving \$25.00 for each beaver taken. The Board then asked Atty. Moren to check if the RRWD would have the authority to remove beaver in the Watershed District.

Scott Habstritt reported having drainage problems south of his land, along Co. ditch 7 and 61, and asked if either culverts could be placed or a dike built. After discussion, a motion was made by Steve Erickson to approve the placement of three culverts and install one trap along Co. ditch 7 and 61, seconded by Farrell Erickson. Carried - unanimous.

Mr. Habstritt also asked about the completion of the dike north of his land. Eng. Rood informed him that the Corp. of Engineers would be sending out a elevation report and he will be notified of their findings as soon as possible.

Eng. Rood reported the following:

HAY CREEK - submitted corrected drawings. The cost of this project is 1.6 million dollars. The RRWD's share would be \$500,000.00. Will try and meet with landowners some time in June.

LAKE BOTTOM - had meeting with DNR and will be sending them a preliminary concept of this project.

DUXBY LEVEE - will call the Corp. to let them know how well the project is going.

SD #51 and ROSEAU DAM - too wet.

PALMVILLE - met with DNR and they approved the revised design. Will start on preliminary reports and applying for permits.

CORP. PROJECT - received resolution of support from the City of Roseau.

Eng. Rood reported the following:

SD #51 - Met with Gustav Kveen and went and looked at his bridge. The Board is aware of this reoccurring problem. Some solutions discussed were replacing the bridge, installing a floating boom, off channel storage or buying the land around the area for a project.

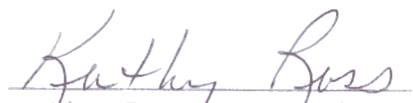

BOARD OF MANAGERS HELD AUGUST 4, 1992

Meeting called to order by Chairman Kelman Kvien at 7:30 p.m. in the Watershed Office in City Hall. Board members present were Kelman Kvien, Farrell Erickson, Steve Erickson and Allison Frislie. Others attending were Eng. Omar Rood, Atty. Pat Morel and Sec. Kathy Ross.

Motion by Steve Erickson to approve June minutes, seconded by Farrell Erickson. Carried - unanimous.

Note: There was no regular meeting held for July as the majority of Board members were unable to attend.

PERMITS:

Motion by Steve Erickson to approve permit for Ken Wojciechowski allowing him to add fill along the river bank to build storage shed, seconded by Farrell Erickson. Carried - unanimous.

Motion by Farrell Erickson, seconded by Steve Erickson to approve Wikstrom Telephone permit to put in fiber optic lines, subject to the proper burial depths. Carried - unanimous.

Motion by Allison Frislie to approve Kittson County permit for replacing bridge and installing two 9 x 10 culverts, at Cutoff 10, County Road 4, seconded by Farrell Erickson. Carried - unanimous.

Eng. Rood reported the following:

SD #51 - submitted two bills for the RRWD's share of the cost of spraying Cutoff 10. Will call Jack Grahn on removal of sandbar east of 310.

ANNUAL REPORT - sent to printers.

Will make a response to Lake of the Woods regarding their Comprehensive Water Plan, stating the plan does not have an adverse impact on the Roseau River Watershed District.

ROSEAU LAKE - met with Corp. need concept. The original design makes this a 1.5 million dollar project.

CUTOFF TWO - denied transfer of CRP contract, will send an appeal.

CEDAR BEND - response from Brian Dwight that land can only be removed from a Watershed District by having a hearing with the State of Minnesota. However, the RRWD may drop land from the SD #51 tax roll. Will inform Bob Phillipe of this.

LOST RIVER - met with landowners and SCS on the possibilities of the project. Discussion on drainage designs.

ROSEAU DAM - after much discussion regarding the safety of the dam, a motion was made by Steve Erickson to have Eng. Rood apply for a dam modification permit from the DNR. Seconded by Farrell Erickson. Carried - unanimous.

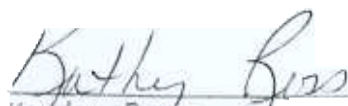
